

As you may imagine, there are lots and lots of other things which have to be dealt with, which cannot possibly be covered in a summary like this. There is rarely a day that goes by without something needing our attention. It is our intention that all these details will be covered in future bulletins, so that, in due course, you will know everything we do.

Just as an example of something that has been going on, I will outline some work concerning the street lighting near the Water Treatment Works. Having lost the power and illumination from the single street lamp quite a long time ago, the committee has been trying to solve the problem within a sensible budget (we had been quoted £9k to repair the lamp). Eventually, after going up several blind alleys, Neil Webster helpfully found some small, low cost PIR solar lights, which he fixed to his fence. We felt these offered a good initial solution, so more of these have been purchased and fitted. It is hoped that the new solar lamps will provide improved security and illumination, whilst a long-term solution is investigated.



As you know the regular AGM, planned to be held in September, was postponed. The committee hopes to announce a convenient date for the AGM to take place in the New Year, when we can get together and discuss the Village Estate.
